11) 安全守卫员(Safe Guarding Officer)

新加坡体育理事会从 2018 年起开始制定有关安全运动(SafeSport)的政策,并在这几年间逐步的落实了一些计划以防止此类罪案在本地发生。其中一项政策是在体育理事会属下的各个国家级团体内设立"安全守卫员(Safe Guarding Officer)",并提供相关的培训。安全守卫员的职责包括了管理有关保护运动员以避免受到虐待,骚扰或侵犯的政策,及时上报有关事件,和给予受影响的运动员支援和辅导,并在所属团体内宣读相关的知识和政策等等。作为体育理事会承认的国家级体育团体,象棋总会也受邀请参与安全运动的事工。本会也派遣 2 位理事欧木顺,陈茗芳参加了 2021 年 3 月 11 日及 26 日体育理事会所办的安全守卫员讲座。这两位理事也正式成为我们的安全守卫员。

The global Covid-19 pandemic has affected many of the activities and program planned and will

possibly stretch to the last quarters of 2021. Notwithstanding this, we continue to plan ahead. Key initiatives include a greater focus to engage the Xiangqi community and co-create broad strategies to help realise our high-performance ambitions as well as make our sport more accessible.

As the Association's premise continues to close to the public, SIXGA has decided to carry out renovation to its premise. The renovation work will begin in May/June 2021 and will be completed by August.

SIXGA will actively encourage and organize competitions using internet platforms. We continue to publish electronic bulletin and newsletter periodically to engage the Xiangqi community.

As Xiangqi has been included in the 2021 SEA Games and 2022 Asian Games in China, SIXGA will focus in the selection and training of our best players to participate in these two events.
