#### **FUTURE PLANS AND COMMITMENTS**

SIXGA's key objective is still focusing on engaging the Xiangqi community, co-create broad strategies to help realise our high-performance ambitions and make our sport more accessible.

Upon the completion of the renovation work, and gradual relaxation of the government's restriction due to Covid-19 pandemic, SIXGA re-opened its door for the members to play Xiangqi in October 2021. We also staged the "Bai-Jiu" Cup Xiangqi Open Competition and 2<sup>nd</sup> Xing-Tian Cup Xiangqi Masters Championship competition in-house in February and March 2022 respectively.

SIXGA will actively encourage and organize competitions both physically and internet platforms. 2022 National Championship will be stage in-house in April 2022. We continue to publish electronic bulletin and newsletter periodically to engage the Xiangqi community.

As Xiangqi has been included in the 31st SEA Games and 19<sup>th</sup> Asian Games in China, SIXGA will focus in the selection and training of our best players to participate in these two events. SIXGA will send 4 athletes to Vietnam to participate in the SEA Games in May.

Where such conflicts exist, the Executive Committee will evaluate whether any potential conflicts of interest will affect the continuing independence of the Executive Committee members and whether it is appropriate for the Executive Committee Member to continue to remain on the Executive Committee.
